An appeal has been made to the Secretary of State against CWaC's decision to refuse to grant planning permission. Following a High Court challenge to the Inspector's decision on this appeal dated 27 October 2016, the Court has ordered that the appeal be re-determined. This does not necessarily mean that the Inspector will reach a different overall decision. The appeal will be re-determined following a hearing. All representations must be received by 4 January 2018. Representations submitted after the deadline will not usually be considered and will be returned.
