**21.87 CHAIRS REPORT**

The Chair gave his report as follows:-

As we come to the end of a difficult and unusual 2 years, and the lock down begins to ease, it seems fitting to reflect on what we have achieved and look forward to the projects we would like to pursue in the future.

Despite the restrictions imposed on us by COVID, I feel proud of the work that we have managed to carry out.

- New Inclusive Equipment in the Play Area
- Trees made safe on the Parish Field and Car Park
- Jubilee Field cleared and almost ready to be open to the Public, with plenty of new plants and hedging.
- New Lease for the Scouts that has enable them to get the Funding for their current Fencing and Landscaping Project
- A new CIO and Lease for the Community Centre, enabling them to bring lots of volunteers together and raise over £70,000 for refurbishment
- Christmas, Easter and VE Day Celebrations and Activities, bringing the Community together.
- Helping with the Food Bank, for the most vulnerable.

- Dog Park improvements, to make it safer for the animals, and easier for wheelchair access.
- Helping the allotments and enabling them to grow as fast as their vegetables.
- Setting up CCTV around the Community Centre, to better protect the Parish Assets.
- Installing Video Conferencing, that has allowed Socially Distanced meetings through the pandemic.
- New LED lighting on the Car Park
- Community Shed for local group access as well as our Christmas Assets.

We have some dedicated, hardworking members of the public that despite not being Parish Councillors, have stepped up and taken responsibility to help us with such things as the Play Area, Jubilee Field, Trees on the Parish Field and the Website. Your commitment has not gone unnoticed and we are all very grateful.

We have done this through a time of ever changing rules and health fears, caused by a pandemic that has affected us all, and sadly taken many that we love in the village.

But we must not rest on our Laurels, nor dwell on the past, because today marks the beginning of the next phase, and there is plenty more that can and must be done.

- Jubilee Field must be open to the Public, so they can start to reap the benefits.
- We must take over and refurbish the Second Play Area on the New Estate.
- We must continue to press Cheshire West to allow us to take ownership of Pogos Wood, so that we can make it a useable asset to the community.
- We must restart the Active Elton Project, so that the Parish Field can become an asset to the village, and help improve the health and wellbeing of the Community.
- We must work with the Allotments to improve and use the are that is currently overgrown and unmanaged.
- We must help bring community groups together
- We must work with the other local Parish Councils, to see how we can improve services and reduce costs.

For us to succeed, as a Parish Council, we must learn to work together. I believe that we have a wide selection of Councillors, in terms of age and outlook, which should serve our community well, as we represent many groups within the village.

This does, however, mean that we do not always agree with one another, but we must learn to respect each other opinions, as I think that the bickering and infighting within the Council, that has gone on for years, does not help the people that elected us, and just makes us look foolish.
