(1) Community Tensions

Loose dogs have been discussed with authorities and the traveller camp.

(2) Planning

Woodland Place – Land extended without planning has been built on. If no one is claiming the land then it is not enforceable, no one has come forward to claim the land. A structure is now in place, possibly wooden. Planning permission has not been received.

Little Meadow – Enforcement has run out and another visit is due. The site has not complied with any of the conditions on the site. Permission for 2 permanent families and 6 transient pitches. Position is now that CWAC can challenge this site in Court and possibly have it closed.

The Stables – Changed hands due to deaths and no named person on site due to persons passing away. Needs to be resolved with the new owners. Rob Charnley from Planning Department at CWAC and Dawn to visit.
